Audit trails and audit reporting to promote transparency



Track and manage different versions of training content

These updates may be small or large, but they impact compliance, especially when determining which teams comply or not.

If one healthcare professional was due for recertification in a specific skill in January of one year and took the appropriate training, they would be considered compliant until that certification expired. However, if the training was updated with new regulations in the summer of the same year, that healthcare professional would not be up-to-date on industry standards. This is where content versioning is essential. With the ExpertusONE platform, managers can


see exactly which version of the course was taken and when and then determine if the learner needs to be recertified with a newer course.






5 Follow industry compliance standards
